EVROPSKA KOMISIJA,

Uzimajući u obzir Ugovor o funkcionisanju Evropske unije,

Uzimajući u obzir Regulativu (EU) 2018/848 Evropskog parlamenta i Savjeta od 30. maja 2018. godine o organskoj proizvodnji i označavanju organskih proizvoda i stavljanju van snage Regulative Savjeta (EZ) br. 834/2007 (1), a posebno član 46(1) te Regulative,

S obzirom na:

(1) Prilog II Primedbene Regulative Komisije (EU) 2021/1378 (2) je usvojen kako bi sadržao spisak kontrolnih organa i kontrolnih tijela priznatih u skladu sa članom 46(1) Regulative (EU) 2018/848 kao nadležnih za sprovođenje kontrola i izdavanje organskih sertifikata u trećim zemljama radi uvoza organskih proizvoda u Uniju u skladu sa članom 45(1), tačka (b)(i) te Regulative.

(2) Član 46(2) Regulative (EU) 2018/848 utvrđuje kriterijume koje kontrolni organi i kontrolna tijela moraju ispuniti kako bi bili priznati u skladu sa članom 46(1) te Regulative. Delegirana Regulativa Komisije (EU) 2021/1698 (3) utvrđuje proceduralne zahteve koje ti kontrolni organi i kontrolna tijela moraju ispuniti prilikom podnošenja Komisiji svog zahteva za priznavanje koji se sastoji od tehničkog dosijea.

(3) Od usvajanja Primedbene Regulative (EU) 2021/1378, Komisija je primila zahteve za priznavanje, podnete u skladu sa članom 46(4) Regulative (EU) 2018/848, od nekoliko kontrolnih organa.

(4) Komisija je primila i pregledala, u skladu sa članom 1 Delegirane Regulative (EU) 2021/1698, zahteve za priznavanje od 'bio.inspecta AG', 'Caucascert LLC', 'CCPB Srl', 'CERES Certification of Environmental Standards GmbH', 'CERTIMEX, Certificadora Mexicana de Productos y Procesos Ecologicos S.C.', 'Control Union Certifications B.V.', 'Ecocert SAS', 'ECOGLOBE LLC', 'FOOD SAFETY S.A.', 'IMO Control Private Limited', 'Kiwa BCS Öko-Garantie GmbH', 'Mayacert S.A.', 'Organic Control System LLC Subotica', 'Organic Standard LLC', 'Servicio de Certificación CAAE S.L.U.', 'Southern Cross Certified Australia Pty Ltd' i 'Tse-Xin Organic Certification Corporation'. Na osnovu informacija sadržanih u njihovim tehničkim dosijeima,
