



PRIMEDBENA REGULATIVA KOMISIJE (EU) 2021/1378

od 19. avgusta 2021. (konsolidovana verzija 25.10.2025.)

kojom se utvrđuju detaljna pravila u vezi sa sertifikatom koji se izdaje operatorima, grupama operatora i izvoznika u trećim zemljama koji su uključeni u uvoz organskih proizvoda i proizvoda iz konverzije u Uniju i utvrđivanje liste priznatih kontrolnih organa i kontrolnih tela u skladu sa Regulativom (EU) 2018/848 Evropskog parlamenta i Saveta

Član 1

Sertifikat za operatore, grupe operatora i izvoznike u treće zemlje

Kontrolni organi i kontrolna tela koja su priznata u skladu sa članom 46(1) Regulative (EU) 2018/848 će obezbediti operatorima, grupe operatora i izvoznicima u trećim zemljama koji su bili predmet kontrola iz tačke (b.) (i) člana 45(1) te regulative sa sertifikatom koji potvrđuje da su takvi operatori, grupe operatora i izvoznici u skladu sa Regulativom (EU) 2018/848 („sertifikat“).

Sertifikat će:

(a) biti izdat na sledeći način:

(i) u skladu sa modelom navedenim u Prilogu I ove Regulative;

(ii) u elektronskom obliku korišćenjem elektronske Ekspertskog sistema kontrole trgovine (TRACES) iz člana 2. tačka (36), Primedbene Regulative Komisije (EU) 2019/1715 (1);

(iii) mora da nosi kvalifikovani elektronski pečat kako je definisano u članu 3, tačka (27) Regulative (EU) br. 910/2014 Evropskog Parlamenta i Saveta:

(b) omogućiti identifikaciju:

(i) operatora, grupe operatora ili izvoznika obuhvaćenog sertifikatom, uključujući spisak članova grupe operatora;

(ii) kategoriju proizvoda obuhvaćenih sertifikatom, klasifikovanih na isti način kao što je predviđeno članom 35(7) Regulative (EU) 2018/848; i

(iii) njegov period važenja;

(c) potvrdi da je aktivnost operatora, grupe operatora ili izvoznika u skladu sa Regulativom (EU) 2018/848; i

(d) biti ažuriran svaki put kada dođe do promena u vezi sa navedenim podacima u njemu.

Annex II to Implementing Regulation (EU) 2021/1378 is amended in accordance with the Annex to this Regulation.



Član 2

Član 3

Stupanje na snagu i primena

Ova Regulativa stupa na snagu dvadesetog dana od dana objavljivanja u Službenom listu Evropske unije.

Primenjivaće se od 1. januara 2022. godine.
